- Learn the League rules, playing laws, policies and procedures
- Respect coaching staff, parents, and all practice and game property (home and away games)
- Only represent the Glen-Ed Soccer Club in a positive manner

As a player, I will NOT:

- Leave a game field, practice, or team function without my parent / guardian without personally informing the coach
- Use any controlled substance (drugs) unless legally prescribed by a physician; I will inform the coach if the situation warrants
- Drink alcoholic beverages or use tobacco products while at game field, practice, or team function

Violations of this Code of Conduct Agreement may result in verbal warning from coach / Club staff (player and guardian); reduced playing time, suspension of practice and/or game privileges; and removal from the team and Club. I may request a disciplinary hearing with the Club Executive Board to resolve disputes. I will pay for all fees associated with any league or club disciplinary action including all red card penalty fees given to player due to unsportsmanlike behavior.

**PARTICIPATION WAIVER and CONSENT AGREEMENT:** By signing this form, I hereby give my full consent and approval for the Participant listed above to participate as a Club member in all events sponsored by, or coordinated with, the Club or their specific team including league and tournament games and practice sessions for the upcoming soccer season, and will have no affiliation with any other USYSA team.

I understand that there are certain risks of injury inherent in the attendance, practice and play of the Club sport and activities, including permanent disability or death as well as severe social and/or economic loss which might result not only from the Participants' own actions, inactions or negligence, but (and not limited to) the action, inaction or negligence of other participants, the rules of play, the condition of the premises and equipment used, travel to and from activities, weather, and other risks not reasonably foreseeable at this time. I understand that these risks are incidental to participation, and by completing and signing this form I am willing to assume these risks.

In addition to giving my full consent and approval for participation, I also do hereby waive and release the Club, its coaches, managers, officials, league officials, sponsors, supervisors and representatives, including the owners and lessors of premises used to conduct Club games, practices, tournaments, activities, meetings, events, all of which are hereinafter referred to as 'releasees', from any injury that may be suffered by the Participant in the normal course of involvement in the designated Club sport and the activities incidental thereto, whether the result of negligence or any other cause.

I also do hereby certify that the Participant is fully capable of taking part in the Club sport and activities and is healthy and has no physical or mental disabilities or infirmities that would restrict full involvement, except as listed below.

I also do hereby give my full consent and approval to have a Club coach, manager, official, an athletic trainer, and/or doctor of medicine or dentistry or appropriately certified personnel to provide the Participant with medical assistance and/or treatment and agree to be financially responsible for the cost of such assistance and/or treatment. I also agree to save and hold harmless and indemnify all releasees from all liability, loss, cost, claim or damage whatsoever, including death or damage to property, which may be imposed upon said releasee because of any defect in or lack of such capacity to so act or caused or alleged to be caused in whole or in part by the negligence of the releasee.

By completing and signing this form, I also do hereby agree that I shall hold harmless and fully indemnify the releasees hereby released from any and all claims, damages, costs, including attorney fees and causes of action which may arise from any cause made by the Participant and the Participant's attending family and associates, even if the damages, injuries or death are caused in whole or by part by any of the persons or entities I hereby release.
